SUBJECT: MEMBERSHIP CONTEST—1973

The National Activity and Membership Committee is going to give a Quasar Portable 19" Color TV set donated by MOTOROLA as an award for the membership contest covering the period January 1, 1973 thru June 30, 1973. The contest blank appears in the adjacent column.

The following guidelines are furnished to assist you in making this drive successful.

1. ELIGIBILITY:

All members in good standing EXCEPT National Board of Officers, National Executive Secretary, and National A & M Chairman.

No person, having formerly belonged to APCO, will be considered a new member in any chapter unless two complete years have elapsed since his previous membership.

Multiple memberships as described in the Constitution, Section 10, paragraph 1, will not count as new members.

2. CONTEST FORMS:

Will be available from National A & M Committee. They will also be published in the APCO Bulletin and can be reproduced locally as needed.

3. SUBMISSION:

a. The contest form, properly completed membership blank, and dues are to be submitted to the Chapter Secretary-Treasurer. (If no Chapter—send to National Executive Secretary, 105½ Canal Street, P. O. Box 669, New Smyrna Beach, Florida 32069.

b. The Chapter Secretary completes his/her portion, indicating dues have been paid by both recommending member and new member, to the Chapter; then forward contest blank with dues to Executive Secretary, POST-MARKED PRIOR TO JUNE 30, 1973. (NOTE: Please be sure your chapter members get credit for new applicant.)

4. DRAWING:

a. This contest will operate just like a raffle—the more members you bring in the more contest blanks you will have in the barrel.

b. The contest blanks will be retained by the Activity and Membership Committee Chairman for recording Chapter participation, etc.; blanks will then be combined and boxed. A drawing will be made for the winner at the National APCO Conference in Kansas city, Missouri.

c. This method is being used to allow participation of all chapter members including those who feel they could only obtain one or two applicants.

We anticipate more Chapter participation on this year's contest. Please support your Chapter, it makes APCO grow.
