re: Life Memberships

The Executive Committee, at its May 13, 1987 Meeting in Atlanta, approved a Resolution from the Board of Officers which had nominated Will McGibbon, of the FCC's Office of Engineering & Technology, as a Life Member of APCO.

The Florida Chapter Chapter of APCO, in a letter received in the National Office on May 21, 1987, has nominated Joe Nasser, as a Life Member of APCO. It is my delegated authority to evaluate the qualifications of such nominees and make recommendations to the Board of Officers. Joe, by the single qualification of having served a full term as National President of the Association, is qualified to be voted a Life Member. Therefore, it is not necessary to evaluate his many other contributions. The Board of Officers will have to vote its approval of Joe's nomination at its next scheduled meeting--August 22, 1987 in Baltimore, Maryland. The Board of Officers, in turn, will have to make its recommendation to the Executive Committee at its August 23, 1987 scheduled meeting in Baltimore. The Executive Committee, in turn, will have to make its recommendation to the Quorum in Baltimore.

Since the APCO Constitution and Bylaws require that nominations for Life Membership be received in the National Office not less than 90 days before the August 22, 1987 meeting of the Board of Officers, any such nominations received after May 24, 1987 cannot be considered this year.

Therefore, the only two Life Membership nominations to be considered this year are Will McGibbon, whose election is subject to Quorum approval, and Joe Nasser, whose election at this point remains subject to approval by the Board of Officers, the National Executive Committee, and the Quorum.

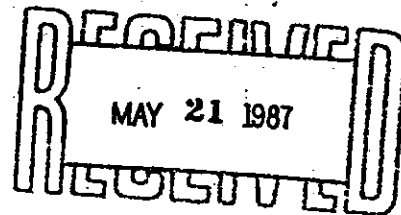
